

Copyright and examination papers

Under the terms of our Copyright Licence you can include extracts from copyright works for examination papers without prior permission. However, this permission applies **only to the examination**: if the examination paper is subsequently used by students for revision purposes either in hard copy in the library for e.g. or electronically, the exception no longer applies.

However, if you only wish to use short quotes, e.g. a single quote of less than 400 words, or several quotes of less than 800 words, it is accepted that as long as you fully acknowledge your source, you don't have to seek permission from the copyright owner.

Copyright and Course Packs

You can copy extracts from books or journals to compile a course pack and make multiple copies of those course packs sufficient for a class. Our Licence allows you to photocopy (with some exceptions) from materials that **are held in the University Library** for each student, including distance learning students, enrolled on a course or module.

You can copy:

- Books – up to 5% or one entire chapter, whichever is the greater;
- Journals – up to 5% or one entire article from an issue of a journal, whichever is the greater.

You will need to obtain a **copyright fee-paid copy** if the University Library does not own a copy of the original publication. You can do this by making an Inter Library Loan request via the library catalogue and making it clear that you wish to obtain the document copyright cleared.

Academic staff who request copyright cleared documents from the British Library copyright fee-paid service, in order that the article can be scanned and added to the mLE, will be charged accordingly.

The cost of a copyright cleared document depends on the individual publisher.

Library Services will charge the academic/School for the whole cost of a copyright cleared article that is to be used in a course pack. See *

If you wish to include **newspaper articles** in your course pack our Newspaper Licence allows you to make up to 250 copies of any one cutting from any one issue of a newspaper without the need for consent from the newspaper. Each such copy or collation of copies must include a notice in the following terms:

NLA Licensed Copy. No further copies may be made except under licence.

Please note that photographs, illustrations or advertisements appearing in newspapers are not covered by the Licence and may not be copied without express written permission from the newspaper concerned.

Additionally, when copying cuttings, you should not make alterations to the size or layout of them beyond what is reasonably required for educational purposes.

When compiling a Course Pack, therefore, find out whether the University Library holds a copy of the publication/s; if it doesn't request a copyright cleared copy from the British Library. If you don't know whose copyright it is, don't use it, and find something else.

This from the Intellectual Property Office:

'The term 'orphan works' is used to describe works protected by copyright in circumstances where the copyright holder cannot be traced - even after a diligent good faith search has been carried out - and hence the copyright work cannot be used without infringing copyright. Any use of a work that is considered to be 'orphan' runs the risk that a copyright owner may come forward at a later date, and take legal action for unauthorised use of their work.'

Copyright and the mLE

Our Licence allows us to **scan** extracts from **hard copy** books and journals in the same way that we can **photocopy** from books and journals i.e.

- Books – up to 5% or one entire chapter, whichever is the greater;
- Journals – up to 5% or one entire article from an issue of a journal, whichever is the greater.

As **Copyright and Course Packs** above, the University Library must own a copy of the original publication, if it does not, then you will need to request a copyright cleared copy.

However, currently there is **only one designated member of staff in Library Services** who is permitted to make the digital copies. **This is because we have to make an annual return to the CLA detailing each scan, author, number of pages and module.**

In order to obtain a scanned copy, take advantage of the **Library Services Electronic Course Pack Service**:

- Speak to your Information Librarian who will discuss with you what it is you wish to scan (we would suggest that it would be something on an Essential Reading List);
- We check that the chapter or article is held in the University Library's stock and that the publication can be scanned under conditions of the Licence;
- The publication is scanned and sent to you in an email: you then add it to the mLE;
- Alternatively you can request a scan via the Library Catalogue.

The same rules apply if you wish to include material from books and journals in a PowerPoint presentation.

Our Licence **does not allow** you to download the full text of chapters from e-books or articles from e-journals and make them available on the mLE. If you wish to include such

material in a folder on the mLE, **you must make a link to the full text document**. The link, called the Persistent link to this record (Permalink) can be found in the full citation of the record (click on the title of the article to find this information).

Copyright and photocopies for library and other use

The photocopied journal article that you receive when you request an Inter Library Loan is only for the purposes of non-commercial research or private study. When you collect your Inter Library Loan, you sign a Copyright Declaration Form agreeing to this.

If you wish to obtain that article for:

- Placing in a library short loan collection for so that students can make further copies;
- Commercial research purposes; or:

- Multiple copies of the same article;
- More than one article from the same journal issue.

The article should be obtained through the British Library's copyright fee paid service

*A copyright fee is added to the standard copying charge payable for each article requested. The copyright fee for each journal title is shown on the British Library's list of Current Serials Received, which can be viewed online at www.bl.uk/serials/welcome.html
