WHEREAS, in accordance with section 124A(3) of the Education Reform Act 1988<sup>(a)</sup> (hereinafter referred to as "the Act"), the Privy Council by Order dated 29th March 1993 made an instrument of government for the Gwent College of Higher Education, being a higher education corporation with respect to which schedule 7 to the Act has effect:

AND WHEREAS section 124A(3)(b) of the Act provides that the Privy Council may by Order modify an instrument of government of any such higher education corporation:

AND WHEREAS the Privy Council by Order dated 16th April 1996 modified the instrument of government to provide for a change of name to University of Wales College, Newport:

AND WHEREAS, in accordance with the instrument of government, the Corporation have resolved to change their name with the consent of the Privy Council:

NOW, THEREFORE, Their Lordships, in exercise of the powers conferred on Them by the said section 124A(3)(b), are pleased to, and do hereby, modify the said instrument of government in accordance with the provisions set out in the Schedule to this Order.

## SCHEDULE

### MODIFICATIONS TO THE INSTRUMENT OF GOVERNMENT REFERRED TO IN THE FOREGOING ORDER

1. In paragraph 1(1), in the definitions of "the corporation" and "the College", for "University of Wales College, Newport" *substitute* "University of Wales, Newport".
2. In paragraph 1(1), in the definition of "the College", for ""the University College"" *substitute* ""the University of Wales, Newport"".
3. In paragraph 1(1), in the definitions of "the Vice Chancellor and Principal", "the Academic Board", and "the Articles", in paragraph 3, sub-paragraphs (2)(b) (twice), (5)(a), (5)(b), and (6) (three times), and in paragraph 6(4), for "University College" *substitute* "University of Wales, Newport".
